for MCEC to strike a balance between maintaining reserves, wisely utilizing bequests, and funding staff and programs to implement the new Strategic Plan for a sustainable future.

3. Staff & Volunteers: Ann L. Schultz continues to serve as the Intentional Interim Executive Team Leader until December 31, 2024, and has brought stability, grace and a refocusing to this role. A Search Committee is at work seeking a new permanent Executive Minister to begin in 2025. This past year also saw a number of significant transitions in key staff and volunteer roles mid-year. Our gratitude and blessings accompany John Reimer, Joan Schooley, Diane Lichti, and Gladys Bender. We welcomed John Head, Laurie Castello, Charles Biswas, Lorie Yantzi, Steph Chandler Burns, Felipe Gonzalía and Charleen Jongejan Harder to significant new staff and volunteer roles. We are blessed by all staff and volunteers in MCEC. Thank you.

And so we need you this weekend – your voice, your engagement, your wisdom, and your prayers as we gather to be the Church. I invite you to engage fully over these two days. Celebrate milestones, new congregations, and ordinations; ask questions that you are not sure about or to probe a little deeper; speak boldly and with kindness; greet old friends and make new ones; pray and worship. We want and need your voice. Let us be the Church together.

## Meet Doug Klassen



Doug is Executive Minister of Mennonite Church Canada. He grew up in Ontario in both the Russian Mennonite and the Amish Mennonite traditions. "I have memories of sitting in a white shirt and gray wool pants in the Blake Mennonite Church west of Zurich - the first Amish Mennonite Church building in Canada," says Doug. Tracing MCEC's history, Doug will reflect on who MCEC was, is and is becoming: a diverse, multi-voiced, intercultural community.

Raised in the Vineland area of Ontario, he and his wife live in Manitoba where they attend Bethel Mennonite Church. "I'm excited to be returning home to speak at this year's Annual Church Gathering," says Doug. "It was my experiences in the congregations of MCEC that instilled in me a deep love for Christ and the Church and prepared my heart to hear a call to ministry... and I am so incredibly grateful."

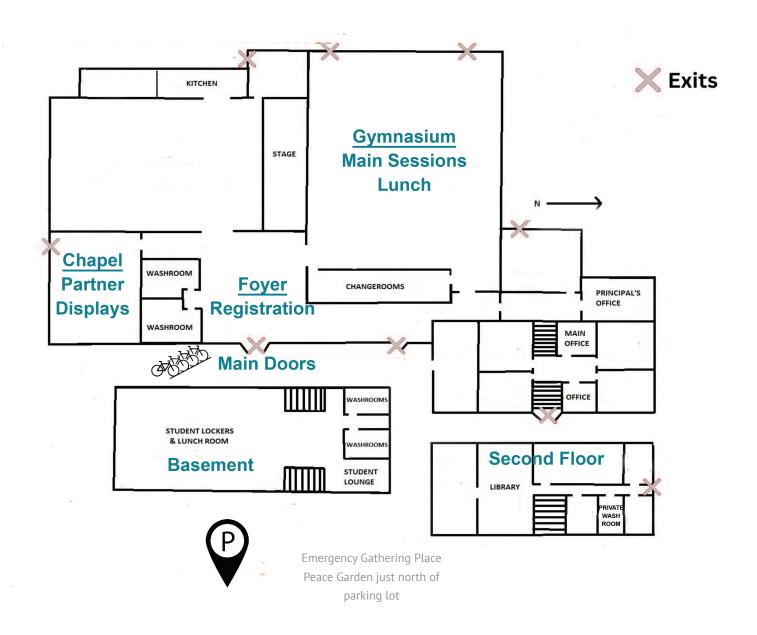

am passionate about strategic plans! Creating a strategic plan establishes a clear sense of direction for an organization, firstly, establishing overall goals and then moving the goals into and a plan to achieve these goals. A strategic plan provides the opportunity for an organization to reflect collectively on where it wants to go over the next three to five years, and then allows its employees to be innovative and creative in its implementation. Finally, a strategic plan allows the organization to be proactive as it looks to the future, rather than reactive. For all these reasons, the MCEC Executive Staff Team and Executive Council are excited to share the plan "Growing into the Future" with you during this year's ACG!

Plans for MCEC's strategic plan were spearheaded by Leah Reesor-Keller, former Executive Minister for MCEC, who, from 2020–2022, facilitated "Courageous Imagination," a visioning and prioritizing process that led to fresh ideas regarding our shared identity, vision, purpose and values. Coming from that process, five priorities were defined: navigating change, developing leaders, collaborating with congregations and ministry partners in support of engaging youth and young adults in intergenerational discipleship, embracing diversity and seeking peace and justice.

In 2022, MCEC congregations endorsed these priorities, and over the last nine months, the Executive Team and MCEC staff have been hard at work to create the plan. As a team, we have shared multiple conversations around various tables to discuss MCEC's strategic priorities, and imagine how they could be realized into the plan. Historical documents

and previous strategic plans were also reviewed, allowing for this input to be integrated into the plan as well.

We remained committed to honoring MCEC's purpose and identity.

MCEC is grateful for the capable facilitation and support we received from Dr. Rebecca Sutherns from Sage Solutions, who worked with the Executive Team and helped us to integrate and incorporate the input and insights from our conversations and collaborations into a plan that included setting goals and objectives for the next several years.

The Executive Council endorsed the plan at our November 2023 Board meeting and since that time, the Executive Team has established the key tasks for the coming year. This weekend, you will hear more about the four goals: relevant resources, intentional growth, strong evidence and sustainable organization, and the Executive Team looks forward to sharing about the tasks we hope to accomplish for the 2024-2025 year.

In order to achieve these goals and tasks, we remained committed to honoring MCEC's purpose and identity.

# JUNE 13, 2024 SPECIAL DELEGATE MEETING ONLINE

s messaged in February, the Executive Council and Executive Team have intentionally decided to delay the vote on MCEC's 2023 audited statements. MCEC's fiscal year-end is January 31, leaving three months to complete the audit and distribute the audited financial statements. This has always been a tight timeline for MCEC Finance. With continuing staff transitions, and as a way to avoid the possibility of last-minute postings of the audited financial statements, the intentional delay allows MCEC and the auditor to complete this important work thoughtfully and thoroughly. We will also defer the vote for approval of a financial auditor for the fiscal year ending January 2025.

We will present the internal financial statements (pg 29), as has been our practice, at the Annual Church Gathering on Friday, April 26, 2024. There will be the opportunity to discuss these statements at the ACG, however, the vote to accept the audited financial statements and the approval of the financial auditor will take place via Zoom during a special meeting of delegates on Thursday, June 13 at 7:00 p.m. We anticipate this will be a short delegate meeting. This delayed vote is in full compliance with the legal requirements of the annual meeting.

Minutes of MCEC's 36<sup>th</sup> Annual Church Gathering Rockway Mennonite Collegiate, 110 Doon Rd, Kitchener, ON Friday, April 28, 2023 7:00 pm

#### 1. OPENING WORSHIP

Welcome - Arli Klassen, MCEC Moderator, welcomed everyone in-person and streaming online.

- a) Land Acknowledgement Ron Flaming, MCEC Truth and Reconciliation Working Group, presented the land acknowledgement.
- b) **Annual Church Gathering Theme** Ann L. Schultz introduced the theme of Transformed Inspired Called from the courageous imagination process.
- c) **Call to Worship and Opening Prayer –** Norm Dyck, Mission Minister, and Marilyn Rudy-Froese, Church Leadership Minister, gave the call to worship and opening prayer.

Brandon Leis and the band led two songs.

#### 2. WHERE DOES OUR TRANSFORMATION, INSPIRATION, AND CALLING COME FROM?

Norm read Hebrews 12:1-3.

Fanoise Legesse, MCEC Intercultural Mission Minister, spoke on the theme "Where does our transformation, inspiration, and calling come from?" Change is painful and beautiful.

Sixty years after Jesus' birth, drastic change happened. Jews excluded Christians from knowing Jesus. When you do not know how to face these changes, you have clouds of witnesses to guide you. We are followers of Jesus. Why should MCEC continue and press on following after Jesus? Because the race has not changed. Whether we like it or not we belong to those people who followed Yahweh. We cannot change the race, we have to fit ourselves to the race. Yield to the leaders and follow with joy. He is with us, and we will be transformed.

Arnold Neufeldt-Fast (Community Mennonite Church of Stouffville), and Rebecca Riek (First Mennonite Church) responded to Fanosie's inspiring call.

3. **CHURCH MEMBERSHIP TRANSITIONS & WELCOME** – Delegates welcomed two new churches into provisional membership and two into full status membership. Norm Dyck, Mission Minister, reminded everyone of the process for provisional and full status membership. The process begins and continues with relationship. Norm listed the criteria that guide the relationship and qualifies congregations for provisional and full status membership.

Norm introduced the two new provisional membership churches and their representatives:

- a) Église Bethésda Mennonite de Saint-Hyacinthe Pastor Amuri Ayeba
- b) Église Jésus-Christ Appelle Tous Pastor Cyprien Muteleka

Each church received a certificate and a plant as a symbol of their new membership status.

Pastors Amuri Ayeba and Cyprien Muteleka Kibukila prayed for MCEC in their own languages.

Norm introduced the two new full membership churches and their representatives:

- a) Hochma Pastor Lyne Renaud
- b) Shalom Worship & Healing Centre Pastor Jonathan Abrham

Each church received a plaque and gifts as tokens of their full status membership.

Pastor Lyne Renaud and Jonathan Abrham prayed for MCEC in their own languages.

Norm announced that provisional membership status was withdrawn from Bethel Ethiopian Evangelical Church. This congregation has ended their relationship with MCEC.

#### 4. INSTALLATION OF PASTORS & MILESTONES

Marilyn Rudy-Froese, MCEC Church Leadership Minister, recognized ordination and congregational milestones. Marilyn recognized pastors new to MCEC or newly credentialed in the past year. Following a litany, newly installed pastors signed their covenant partnership with MCEC.

Marilyn spoke a word of blessing to the pastors.

Brandon Leis and the band led a song.

5. **OFFERING** – Offering was received to support MCEC's strategic priority, Developing Leaders.

Shalom Worship and Healing Centre continued worship with music.

Brandon Leis and the team led the sending song.

#### 6. ADJOURNED

The Friday night session ended at 9:25 pm, followed by a reception to welcome new congregations.

#### 1. OPENING WORSHIP and WELCOME

Arli Klassen, MCEC Moderator, opened the meeting with a welcome in multiple languages. She outlined the schedule for the day.

Land Acknowledgement and Prayer – As a member of the MCEC Truth and Reconciliation Working Group, Melissa Miller offered an opening prayer of deep gratitude to Creator God and acknowledged the Indigenous land we are living and working on.

Elaine Ranney, Rockway Mennonite Collegiate principal, gave a presentation on Rockway Mennonite Collegiate as an MCEC partner.

Ann L. Schultz and Steve Cox, MCEC Events Coordionator, announced that Mennonite Spiritual Directors of Eastern Canada are tending this event with prayer.

The Listening Committee is Ly Vang, Ron Mathies and Janet Bauman. Aldred Neufeldt is the Parliamentarian.

Marcus Shantz, Conrad Grebel University College president, gave a presentation on Conrad Grebel University College as an MCEC partner. CGUC is celebrating their 60<sup>th</sup> anniversary this year.

The worship continued with singing.

#### 2. MENNONITE CHURCH CANADA REPORT

Doug Klassen, MC Canada Executive Minister, brought greetings from Mennonite Church Canada's regions across the country.

Bock Ki Kim and Sook Young Park, Mennonite Church Canada Witness workers in South Korea, used a singing bowl to open their presentation. It is a ritual used to open the school of peace where Bock Ki teaches. MCC and MC Canada's influence started the Korean Anabaptist Centre and new congregations in South Korea. He invited everyone's prayers; good things are happening in South Korea.

Tim Wiebe-Neufeld, MC Alberta Executive Minister, brought greetings from the 12 congregations that form MCA.

#### 3. INTRODUCTION OF EXECUTIVE COUNCIL & STAFF CHANGES

Arli Klassen, MCEC Moderator, introduced the executive council and Ann L. Schultz as Intentional Interim Executive Team Leader. This last year was more challenging than others because of staff transitions: Sean East, Finance Manager, resigned in October and Leah Reesor-Keller resigned in October. Ann Schultz accepted a leadership position that began in January. She will lead in this

capacity until April 2024. Arli gave a shout-out to all of MCEC who have shown their commitment in the past year of numerous changes.

#### 4. ACCEPTANCE OF 2022 ANNUAL CHURCH GATHERING MINUTES

Steph Chandler Burns, Executive Council Secretary, presented the minutes of the 2022 Annual Church Gathering.

Motion: On behalf of the Executive Council, Steph Chandler Burns moved and John Findlay, Hanover Mennonite Church, seconded the motion to accept the minutes of the 35<sup>th</sup> Annual Meeting of Mennonite Church Eastern Canada, held April 29 and April 30, 2022. Carried.

#### 5. ACCEPTANCE OF EXECUTIVE COUNCIL ACTIONS

Steph Chandler Burns, Executive Council Secretary, presented some corrections and additions to Executive Council actions printed in the discernment document.

They added actions from the April Executive Council meeting that were not included in the discernment document, as

- On the recommendation of the Finance Council, Executive Council adopted the Audited Financial Statements for Fiscal Year 2023 as printed, for delegate approval at the 2023 Annual Church Gathering
- Executive Council approved Finance Council's recommendation to appoint E.M. Simon, Professional Corp Association, as Auditors for Fiscal Year End 2023

Motion: On behalf of the Executive Council, Steph Chandler Burns moved and Nancy Frey, Listowel Mennonite Church, seconded the motion to approve all actions taken by the MCEC Executive Council for the year May 2022 to April 2023, with corrections as noted. Carried.

#### 6. **REVIEW OF YE2023 FINANCIAL STATEMENTS**

John Reimer, MCEC Operations Director, reviewed the financial statements for the year ending January 31, 2023. He commented on the more significant numbers and changes.

- Decline in congregational had serious impacts on MCEC's financial health
- Reduction in individual and church giving left shortage of \$114,000
- Interest shortfall in revenue income was \$157,000
- Operating expenditures were over-budget by \$26,000; this number is remarkable in that the budget was over only 2%, given numerous changes in MCEC
- Total revenue is a little over \$2 million
- Paid out over \$1 million to partners
- Need to transfer from Faithful Steward Fund, according to policy to cover shortfall
- Last year approved \$156,000 from Faithful Steward Fund, and this year will transfer \$157,000, resulting in a balanced budget

#### 7. ACCEPTANCE OF YE2023 FINANCIAL STATEMENTS

Motion: On behalf of the Executive Council, John Reimer moved and Victor Klassen, Stirling Avenue Mennonite Church, seconded the motion to accept the audited financial statements for the fiscal year ending January 31, 2023 as printed. Carried.

Delegates commented the following in an open mic

- Cyrille Fopoussi, Avon Church: Is the deficit something that Executive Council has a concern about? The level of awareness of the wider church is probably lower than he has personally witnessed. It is obvious that it is reflected in donations. This is not only about money, but people deeply believing. They do not understand the purpose.
  - Rich Steinmann, Executive Council Treasurer responded that the Executive Council is concerned and looking at different ways to address reduction in giving.
  - Arli Klassen, Moderator, added there are many questions about what the church will look like in 15-20 years. Strategic plan is addressing how to "be," perhaps a smaller church, but different than who we are now.
- Tobi Thiessen, Toronto United Mennonite Church: expressed concern about approving audited financial statements when they were not in the discernment documents. She would like to see a graph of giving in the last 10 years
  - Arli: the practice in the past years was to present the internal financial statements which give more detail than the audited financial statements.
  - John has information on giving patterns from the past ten years and will make it available for anyone interested. In the past ten years, we have generally had a 2-3% reduction every year
- Greg Chandler Burns, Waterloo North Mennonite Church: cautioned MCEC to have these statements completed well before ACG. Understands there have been many changes but need time to review it
  - Auditors did not have concerns resulting from the audited statements
- Steven Reesor-Rempel, Stirling Avenue Mennonite Church: What is the current balance in the Legacy Initiatives Fund?
  - Arli informed him the balance is \$3.3 million, according to the audited statements

#### 8. VIDEO – TRANSFORMED, INSPIRED, CALLED,

Ann stated how it is a pleasure to serve in her role. The last four months have been filled with many challenges and rewards. MCEC is finding ways to nurture the vision and values of MCEC.

Congregations should receive a survey in mid-May, with an opportunity to share input on what MCEC is doing well, and how MCEC needs to be strengthened. This survey will help inform how we need to change, tweak, and inform structures and policies. Details will be sent in the coming weeks.

Ann introduced a video that reflected: *Transformed. Inspired. Called.* in the Mennonite Church Eastern Canada office. This is grounding their work, along with the mission statement. She invited congregations to think about how they are inspired and send a video to MCEC. It could be viewed at next year's ACG.

#### 9. REVIEW OF SPENDING PLAN

Arli Klassen, Ann L. Schultz and John Reimer introduced a spending plan for 2023-2024.

#### Comments from the floor

- John Findlay, Hamilton Mennonite Church: encouraged a more direct line from MCEC to congregations
  - Challenged congregations and individuals to find ways to designate money for MCEC The connection to leaves on trees in an aspen forest is tenuous at best
- Victor Klassen, Stirling Avenue Mennonite Church: the givings for next year are more likely to be down \$30,000 to \$60,000
  - MCEC is still budgeting more than actually received last year
  - When people pre-prioritize, the normal approach is that you cut some things to do new things. How will the delegate body be involved in the hard part?
  - Arli responded that every year we are bringing new congregations to MCEC. Are there more possibilities with them?
  - Appreciated point on prioritizing and there will be work done on that
  - How will delegates be involved? Ann replied that the survey will be an opportunity for feedback on what we do well and how what we need to strengthen distributing mid-May
- Kandace Boos, Stirling Avenue Mennonite Church: read a prepared statement. She was deeply hurt hearing the evening before there were no new passionate candidates in pastoral ministry. We are here but do not look like people in power. We are women, people of colour and gender diverse who can give our gifts to congregations in MCEC
  - Need to courageously dream what leadership will look like with our diversity of pastors
- Elizabeth Willms, St. Catharines United Mennonite Church: it is helpful to have financial statements presented on screens, rather than through discernment docs where she would be very lost
- Judith McCartney, SoulHouse Church: thanked the greater community of MCEC for supporting the ministry she does in Toronto
  - She is blessed by the Legacy Initiatives Fund
  - How do we review the measurable of these plans?
  - Want to make sure return is not just home-based
  - Judith concluded she wants MCEC to be known for investing in the future
- Maurice Martin, Mannheim Mennonite Church: We need fundraiser to speak to particular programs that energize people to give funds
- Ivan Unger, Wanner Mennonite Church: was saddened that volunteerism is not accepted in our churches and institutions anymore. We need to expect it.
  - Pleaded for institutions to engage in volunteers roles
- Jim Brown, Tavistock Mennonite Church: asked about the strategy of endowing legacy funds when foundations across Canada are spending-down
  - MCEC replied, we have not used the word "endowments" but investments and policy needs to be developed
- Colin McCartney, Connect City, has planted four churches in unchurched communities through the Legacy Initiatives Fund
  - He is concerned if we put money into sustainability, how will we grow?
- Paul McDowell, Community Mennonite Church of Stouffville: recognized the very hard work of Finance and Executive councils to build a sustainable future Their financial plan is transparent and presents their values

- Alison Gingrich Regehr, Stirling Avenue Mennonite Church: As we live into our values for Shalom for all creation, will future investments be made in fossil-free fuel portfolios?
   We will develop an investment committee in the next year
- Randy Lepp, Learnington United Mennonite Church: Can you help us re-teach how to care for others before ourselves?
- Bimal Thambyah, Montreal Mennonite Fellowship: review all the facts about people get to know our neighbours
- Nancy Mann, St. Agatha Mennonite Church: spoke in support of the spending plan in a time
  when MCEC has had significant transitions in senior leadership, recognizing a reality and
  resources we have and coming up with a plan that is sustainable for the present and hopeful for
  the future

#### 10. ACCEPTANCE OF SLATE

Gladys Bender, Gift Discernment Committee chair, presented the slate of volunteers, with a couple of changes.

The Executive Council is considering revisions to their relationship with the Gift Discernment Committee and asked Gladys to extend her term as chair for an additional five or six months.

Gladys thanked those who agreed to serve on councils, committees and boards on behalf of MCEC, and to those who have completed their terms.

Motion: Gladys Bender moved, on behalf of the Executive Council, and Gayle Harder, Community Mennonite Church of Stouffville, seconded the motion to accept the 2023-2024 slate as presented. Carried.

Arli Klassen prayed for the people who are serving in these roles.

#### 11. ACCEPTANCE OF THE SPENDING PLAN & PRAYER

Motion: On behalf of the Executive Council, Arli Klassen moved and Cyrille Fopoussi, Avon Church, seconded the motion to accept the 2023-2024 spending plan as printed. One opposed. Carried.

Arli Klassen prayed gratitude for the financial resources that are available to staff in the coming year and for donors who shared their resources.

#### 12. ACCEPTANCE OF AUDITORS FOR 2023-2024

Motion: On behalf of the Executive Council, Rich Steinmann moved and John Enns, Waterloo-Kitchener United Mennonite Church, seconded the motion to appoint E.M. Simon CPA Professional Corporation as auditors for the fiscal year ending January 31, 2024. Carried.

#### 13. GRATITUDE TO ARLI KLASSEN

Ann Schultz thanked Arli Klassen for her ministry to MCEC for the past seven year term, two years as a director and five years as Moderator. Ann presented Arli with a gift.

Brandon concluded this agenda with a song: Open my Heart/Abre mis corazón.

Doug Amstutz, AMBS Development Associate for Canada, gave a presentation on Anabaptist Mennonite Biblical Seminary as an MCEC partner.

Brandon Leis and the team lead two songs, "Could It Be That God is Singing" and "Take, O Take me as I am."

#### 17. PANELIST RESPONSES

Charles Tabena, pastor of Centre Béthésda Mennonite de Québec, and Sarah Garnet, Faith Mennonite Church, responded to the question, "As a part of MCEC and a person who is being Transformed. Inspired. Called., how does Hebrews 12:1-3 affect our shared vision and identity in the ministry we have together?"

#### 18. ROUND TABLE DISCUSSION

Each table discussed the same question as the panelists. A few tables shared what they discussed.

- Patricia Regier, Niagara United Mennonite Church: Navigating changes, embrace abundance mentality rather than scarcity mentality
- Berhanu Kumsa, Tsega Bible Fellowship Church transformation process requires three things: 1) Word of God 2) prayer 3) Fellowship Holiness, submission is very important
- Lyne Renaud, Hochma rich conversation, We must run what God has put in front of us. Jesus is the champion
- Alison Gingrich Regehr, Stirling Avenue Mennonite Church: new or old risk of causing change
- Charleen Jongejan Harder, Elmira Mennonite Church: What holds us down? Is dismantling the church actually the work of the Holy Spirit? We are in a big shift. It is worth investing in trust.

#### 19. LISTENING COMMITTEE RESPONSES

As a member of the listening committee, Janet Bauman shared

- the theme of being transformed came through clearly
- We want to be a covenant people
- Globalization of the church is important as it welcomes all
- Worship feels and looks different than 10 years ago. Mono-cultural look changed to multicultural.
- Historical churches have anxiety about decreasing, yet on the other hand we have passionate voices from the younger generation. We need to listen and learn from them. How do we train young children?

The Listening Committee relayed gratitude for Arli's leadership, Legacy Initiatives Fund and a bold and exciting financial plan.

Access to documents was a concern. Provide page references when on stage.

#### 20. OFFERING

Offering was received for Intergenerational Discipleship ministry; faith formation for all generations, especially for young leaders and generations. Ben Cassels prayed for the offering.

#### 21. CLOSING WORSHIP AND PRAYER

Brandon Leis and the team closed with two songs: "Be a Sower" "Sing a New World into Being."

Ben Cassels asked everyone to share what they have learned, seen, and reflected over the weekend to their congregations. He thanked the MCEC staff and all volunteers, host Rockway Mennonite Collegiate, and *Gracies* for the food.

Ben closed with a prayer.

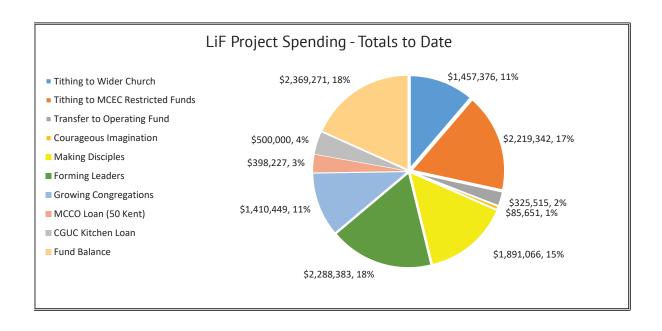

## **BEQUEST FUNDS UPDATE**

#### THE FAITHFUL LEGACY FUND: A NEW PATH FOR SUSTAINABILITY

ast year's update on "MCEC Bequest Funds" (pg. 46-47 of Discernment Documents from 2023 Annual Church Gathering) spoke of a new direction in how bequests are used: shifting from entrepreneurial endeavors towards creating a new income stream for MCEC to aid in long-term financial sustainability.

Over the last year, MCEC Executive Council and Staff have taken the following steps to implement this new approach, including:

1. Creation of a new "Faithful Legacy Fund" (FLF):

This is where all new bequest funds to MCEC will be housed. The Faithful Legacy Fund will be invested in order to create a new income stream for MCEC and also serve as our reserve funds. Additionally, our two previous bequest funds (the Faithful Steward Fund or "FSF" and the Legacy Initiatives Fund or "LIF") will cease to exist and their balances transferred into the new Faithful Legacy Fund. Previous commitments from the LIF, concluding in 2024-2025, will still be honoured.

2. Formation of an "Investment Committee" (IC):

An Investment Committee has been formed (see "Slate" on pg. 28) to oversee the investment of the Faithful Legacy Fund with the purpose of creating a new income stream for MCEC. They have begun creating policy and considering investment return targets.

3. Consultation with Constituency regarding Investment Policies:

In November 2023, an online meeting was held inviting constituency engagement on the creation of investment policies. Further, the Investment Committee has been consulting with other Mennonite organizations regarding their own investment policies and guiding principles.

#### **Looking Ahead:**

At this time, the new Faithful Legacy Fund is not yet generating significant investment income for MCEC. Our best guess is that this will begin sometime between 2027 - 2029. This is based on the knowledge that MCEC will be the recipient of a final installment from a significant previously-known bequest, and also

upon estimates of when MCEC might receive these funds. Once received, these funds will serve as a major initial principal amount for the Faithful Legacy Fund. But the exact timing of all this is unknown.

Additionally, we do not know how much new income from these investments to expect. It will depend on the amount received via bequests and the rate of return on investments. But we do know that it will be at least 3-5 years before these begin to make any impact on MCEC's budget.

The very rough estimate that we are hoping to achieve from investments of the Faithful Legacy Fund starting in 2027 - 2029 is approximately \$500,000/year. To put this into context: even if these funds were available in the current year (which they are not), they would account for roughly 20% of the proposed budget, leaving 80% that is still dependent upon contributions from congregations and individuals.

## We thank God for each and every congregation and individual.

Congregational support remains the largest source of funds for MCEC. This is true currently and will remain true even after this new yearly income from the Faithful Legacy Fund begins to be achieved. So while MCEC is blessed to be able to anticipate this significant new income stream in several years from now, it will not "solve" all financial challenges at MCEC.

Executive Council and Staff know that many congregation's budgets are in a period of significant flux and re-alignment due to broader economic conditions and changes post-pandemic, all impacting the amount of financial support sent to MCEC. Executive Council and Staff continue to work diligently to adjust to these realities, wisely manage

existing reserves, and budgeting in ways that are both responsible and enable the ministry of MCEC to continue now and into the future. Your prayers and wisdom are welcome.

MCEC is blessed to have congregations and individuals who faithfully contribute annually to supporting its ministry and mandate. These are the most essential sources of financial support and stability for MCEC, without which MCEC cannot exist. We are thankful too for all who support MCEC via bequests, which allow for new possibilities and paths of long-term sustainability. We thank God for each and every congregation and individual who gives any amount.

Thank you to all who give to MCEC. This support makes it possible for MCEC to live into our vision of energizing congregations, encouraging leaders, and embodying God's reconciling ministry for all creation.

## **INVESTMENT COMMITTEE UPDATE**

n MCEC Investment Committee has been formed to further support the prudent management of MCEC financial resources and investments. The financial resources include generous bequests past, present and future and are important in supporting the ongoing priorities of MCEC. You can read more about this in the Bequest Update above.

Our committee currently includes Rich Steinmann, Dale Brubacher-Cressman, Ben Eby, Mike Steinmann, John Head, and James Barber (chair). We are fortunate to have a team with strong financial and church experience, working well together to steward investment in our MCEC's future.

The Investment Committee values input from our MCEC constituency in how our available funds are invested. We were thrilled to have strong constituency participation in fall 2023 for an online consultation to help ensure our investments are aligned with our values.

Since then we have looked at investment approaches taken by other large Mennonite groups, and are currently building out an investment policy investment strategy to protect our capital through a balanced portfolio that will be invested in socially responsible ways. We also recognize that decisions around investments can be a sensitive topic, with strong and divergent views in all parts of our church. We plan on continuing to find ways to update and consult.

We also ask for wisdom, guidance, and grace as we all look to make the most of the ten talents we've been given.

Finally, we have been searching for another member both to help the committee and to add to our diversity. Suggestions are welcome.
